Privacy Statement

This Privacy Policy describes your privacy rights regarding our collection, use, storage, sharing and protection of your personal information on the Oasis International Resources (OIR) website, www.oasisresources.org, as well as other websites owned and controlled by OIR. OIR's website may contain links to other websites that are not operated by OIR. OIR is not in any way responsible for the privacy practices, collection, use, or disclosure of personally identifiable information by such websites, nor is OIR responsible in any way for the content of such websites.

OIR strongly encourages all users to be aware when they leave OIR's website and to read the privacy statement of every website visited that collects personally identifiable information.

The Collection, Use, and Disclosure of Personally Identifiable Information

As used in this privacy statement, "Personally Identifiable Information" is personal information that identifies a specific natural person and means: (a) a first and last name; (b) an address, including a street name, city or town, and zip code; (c) an e-mail address; (d) a telephone number; (e) a Social Security number; and/or, (f) an account number or credit card number.

OIR is the owner of all personal information that is collected by OIR on the OIR website. OIR may collect personal information from users and in responses to online surveys on OIR's website.

OIR will not sell or rent personal information to other organizations in ways that are different from what is disclosed in this Privacy Statement.

OIR may use personal information to contact the user about OIR, the goods and services available on OIR's website, and to provide information about other topics and discussion groups.

OIR may disclose personal information to third parties as required or permitted by law.

OIR may share aggregate demographic information that does not contain personal information.

IP Addresses

OIR's website uses IP addresses to help OIR analyze trends, administer OIR's website, track user movement, and gather broad demographic information for aggregate use. IP addresses do not contain personal information.

OIR's website, as with most other Internet sites, utilize "cookies". A "cookie" is a piece of data stored on a user's hard drive that contains information about the user. A cookie does not contain and is not linked to personal information. It does contain a unique identifying feature

that allows the OIR website to recognize you when you return to the OIR website. Your recorded IP address allows OIR to determine what domain you came from (i.e. google.com), but does not give us access to your email address or other personal information. OIR uses this information to help diagnose problems with the OIR website, gather broad demographic information, and evaluate behavior of users on the OIR website.

If a user rejects the cookie, the user may still use OIR's website, but may be limited in some areas of OIR's website.

Various Registrations

In order to receive certain updates or use certain features on OIR's website, a user may have to complete a registration form. During registration a user may be required to provide personal information, such as the user's name and/or an e-mail address. If requested, it is optional for a user to provide demographic information (such as income level and gender) and unique identifiers which enable OIR to provide a more personalized experience on OIR's website.

Newsletters

A user may subscribe to OIR's newsletters or other publications on the OIR website. In that case, OIR will request personal information, such as the user's name, mailing address, and/or an e-mail address. Personal information may be used to send such newsletters and may be used to contact the user about OIR, the goods and services available on OIR's website, and to provide information about other topics and discussion groups.

Anti-Spam Statement

OIR opposes the use of unsolicited commercial email and mass posting to inappropriate newsgroups (spam) as a way to promote or advertise. OIR attempts not to send email to persons who are not related to our projects and services or who have not otherwise requested contact from us, nor do we post advertisements to unrelated newsgroups. If you receive any unsolicited commercial email that appears to be from OIR or an employee of OIR, please notify us immediately.

OIR will reasonably investigate instances of unsolicited commercial email that appears to originate from OIR. If we find persons or entities using OIR's name inappropriately, we will contact our lawyers and take reasonable steps, which may include legal action, to stop the unauthorized use of OIR's name.

Online Surveys

OIR may conduct online surveys, which may request personal information, such as a name, an e-mail address, and/or a mailing address. Information collected by OIR's online surveys may be

used to help OIR understand the interests and concerns of OIR's supporters and website users, and how they perceive OIR and OIR's mission.

Third Party Contractors

OIR sometimes contracts with third-party service providers to serve advertisements (banners, videos, or ads) on our behalf across the Internet. OIR third-party contractors may collect non-personally identifiable information about your interaction with OIR. This Privacy Policy does not cover the collection methods used by these vendors, as they have their own privacy policies.

Is you wish to opt-out of this type of data collection, you can disable cookies in your web browser. However, this may diminish the experience and functionality of websites that your visit, including OIR.

Use of Credit Card Processing Companies

OIR may use credit card processing companies to process and bill customers for donations related to OIR's services and projects. OIR may affiliate with other organizations to provide goods and services related to OIR's services and projects.

When a user provides a donation, OIR may share personal information as necessary to process the donation. Processing companies used by OIR each have their own privacy statement. OIR encourages users to read the privacy statement of our processing companies.

Except as may be required by law, OIR is not responsible for the acts of any of the entities discussed in this section with regard to their handling and treatment of personal information.

Security

OIR's website has security measures in place to attempt to protect against the loss, misuse, and alteration of information, including personal information that is under OIR's control.

However, because of the nature of the threats to the security of information, OIR cannot guarantee that it can prevent security breaches that could compromise information, including personal information, which is under OIR's control.

Marketing

OIR will not rent, sell or trade your personal information to third parties for their marketing purposes or send mailings on behalf of third parties without your explicit consent. OIR may combine your information with information collected from other companies and use it to improve and personalize services, content, and advertising.

Opt-Out

OIR respects user's communication preferences and provides users the opportunity to opt-out of receiving further mailings, phone calls and e-mails from OIR by contacting OIR as directed in this Privacy Statement.
